A RESOLUTION OF THE NORTH BLAINE COUNTY FIRE DISTRICT ADJUSTING AND ESTABLISHING FEES AND CHARGES FOR THE PLAN CHECKS, PERMITS AND ADMINISTRATION OF THE 2018 INTERNATIONAL FIRE CODE AND AMENDMENTS THERETO ADOPTED BY BLAINE COUNTY ORDINANCE 2021-06

WHEREAS, Idaho Code Section 41-253 which adopts the 2018 International Fire Code and amendments thereto provides that the fees and charges for plan checks, permits, and administration of said Code shall be set by Resolution of local agencies such as the North Blaine County Fire District; and

WHEREAS, the North Blaine County Fire District desires to set such fees and charges by this Resolution

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS of the North Blaine County Fire District, as follows:

The following fees and charges are hereby established and shall be paid for the permits, plan checks, inspections and administration of the 2018 International Fire Code and amendments thereto adopted by County Ordinance 2021-06 and Idaho Code.
